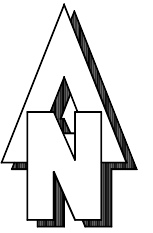
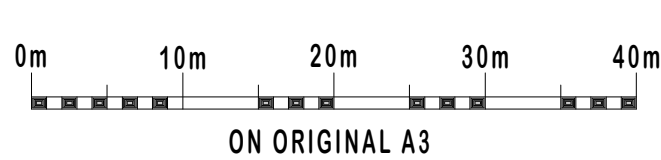


**SKETCH PLAN:

LOCAL AUTHORITY: MADIBENG**

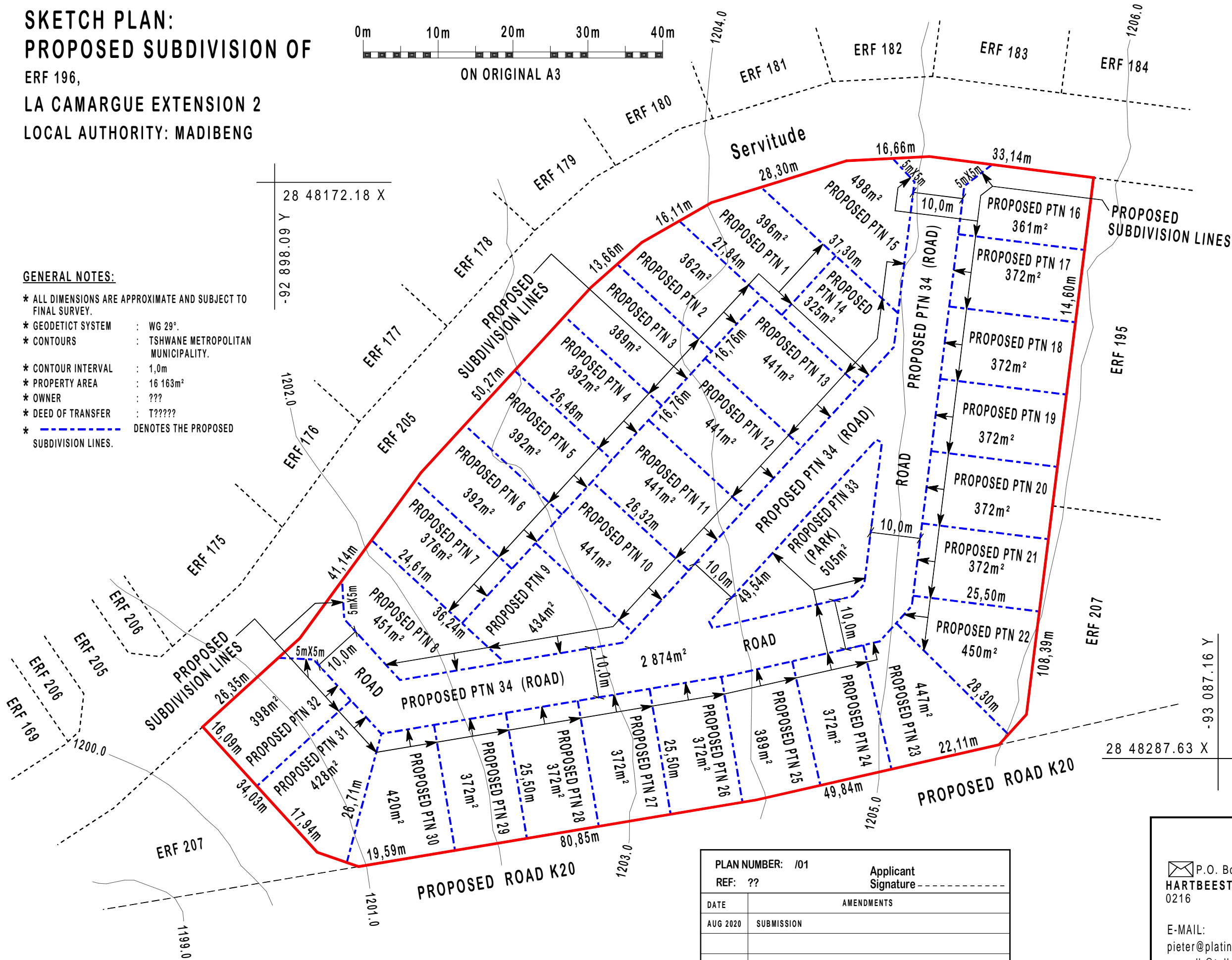
